Mahalo North Coal Seam Gas Project

Resource activity: Site specific petroleum activity

It is advised that Comet Ridge Mahalo North Pty Ltd has lodged an application for an environmental authority in accordance with the requirements of the *Environmental Protection Act 1994*. The environmental authority lodged is A-EA-NEW-100521948.

The application relates to a greenfield coal seam gas (CSG) development approximately 45 kilometre (km) north of Rolleston and 70 km southeast of Emerald, within the Central Highlands Regional Council Local Government Area of Central Queensland. The project is contained within Petroleum Lease (PL) 1128 application and covers an area of 14,000 hectares. The project's life span is estimated to be 30 years and will supply the domestic Australian gas market.

The resource activity is proposed to occur on PL 1128 and will involve the construction and operation of CSG wells (using a combination of vertical and lateral wells), gas and water gathering pipelines, gas compression facility, new access tracks (with existing tracks used where possible), and water management infrastructure.
